

ADMISSION NOTICE

Online applications are invited from the desirous candidates for seeking Admission In Govt. ITI Sopore for the Academic Session 2022-23-24 in various Engineering/Non Engineering Trades having duration of One Year/Six months being run under NCVT/SCVT Scheme and commencing from September 2022.

Candidates having minimum age of 14 Years, as on 1st June 2022, with no upper age bar can apply. The desirous Candidates have to fill up the admission forms online available at ITI admission link (<http://itiadmissions.jkdsd.org>) present on the official website of Directorate of Skill Development J&K i.e www.jkdsd.org.

This last date for applying online is up to **9th of July, 2022**. The details pertaining to trades functioning in Govt ITI Sopore for which admission are to be made for the session 2022-23-24 for Free and Self Financing seat are available on the Portal (itisopore.com) and can also be sought from the ITI.

The candidate have to fill up the complete details which include Basic Details of the Student like Name, Parentage etc. and Qualification Details online in the portal and have to upload the soft copy of the following documents online only.

1. **Marks Certificate of Qualifying Examination.**
2. **Date of Birth**
3. **Category Certificate (SC/ST/Ex. Servicemen/Physically Handicapped/EWS) if any.**
4. **Aadhar Card.**
5. **(Domicile Certificate should be produced at the time of admission in the training section).**

The candidates after finalizing the profile and application online will be required to deposit the print out system generated application at the ITI in the trainings section in which the candidate is applying along with self-attested photo copies of above mentioned required documents at the ITI in the trainings section. The details pertaining to trades functioning in Govt ITI Sopore for which admission are to be made for the session 2022-23-24 are as below.



Important Note:-

1. Selection will be made purely on the basis of Academic Merit obtained by the applicants in their qualifying examination (Both for free and Self Finance seats separately).
2. On successful completion of training in trades running under NCVT/SCVT scheme, certificate will be awarded by National/ State Council for Vocational Training.
3. Candidates who have already undergone training in any of the trades in ITI can apply for admissions in another trade after two years of completion of previous training/ course. However, for the ensuing academic session, their admission can be considered in any trade having poor response.
